ACTIVE PAYMENT PROMOTION RULES

Organizer:

Kcell JSC (Company or Organizer)

Active Payment promotion – a promotional offer (Promotion) run by Organizer in Almaty city, Kazakhstan.

Promotion is run from 10 November 2016 through to 31 January 2017.

Promotion participants are Kcell customers whose mobile numbers are registered to physical persons (except private entrepreneurs) and who have attained the age of 18 years, citizens of the Republic of Kazakhstan or persons with KZ residence permit. The following parties/persons are not allowed to participate in the Promotion: Company employees and their close relatives (spouse, parents, adoptive parents, children, grand/step children, siblings, secondary siblings and grandparents); dealers and distributors of Organizer and their employees; employees of SMSBUS LLP, Almaty SpetsTekhParking LLP and their affiliates; advertising and other agencies associated with the Promotion, or participating therein, as well as close relatives of all of these parties.

1. Promotion conditions

The Promotion is run among the Activ customers who paid for the below listed services using their mobile account, starting from 01.11.2016 till 31.01.2017:

- Payment of public transport fares in Almaty;
- Payment of parking fees in Almaty.

For the purpose of the Promotion, payments made in any given month during the promotional period, starting from 01.11.2016 till 31.01.2017, will be counted.

Promotion results for each service will be announced within 10 business days after the end of each month. The prize winners are picked randomly through random.org website.

1. Winner selection

- **2.1** To determine the winners, the Organizer generates a list of participants who meet the participation conditions for the Promotion.
- **2.2** Winners are selected randomly through random.org website. The list of the participants' payments is uploaded to the website. The Galaxy S7 edge LTE Black 32 GB (the Prize) draw results are entered in the draw records to be signed by the responsible employees of the Organizer.
- **2.3** After the main winners have been picked, the Organizer picks 3 reserve winners.
- 2.4 The winner will be selected within 10 business days after the end of each month during the Promotional period. The prize winner can pick their prize within 2 days from receipt of notice at the nearest Kcell Center. Should the winner fail to appear at the required time and/or meet the requirements stated in these Rules, the prize will go to the first winner on the reserve winner list.

Should the reserve winner fail to appear at the required time and/or meet the requirements stated in these Rules, the prize will go to the second participant on the reserve winners list. Should the

3 DISTRIBUTION OF PRIZES

- **3.1** The representatives of Organizer will contact (call or SMS) the winner using mobile number which was used to make a payment, within 1 day after announcement of the final Results have been announced in order to get his/her identity details and inform about the time and place where he/she can pick up their prize. The winner is required to be physically present at the event, failing which (for any reasons whatsoever) the prize will go to the reserve winner.
- **3.2** B Should the representatives of Organizer, for some reason, fail to contact the winner by the time specified in par 3.1 hereof, the winner will be the first participant on the reserve winners list.

- **6.2.** Organizer reserves the right to amend these Rules by posting the relevant information on activ.kz website.
- **6.3.** Organizer is not responsible for:
- **6.3.1.** a failure to receive or untimely receipt of information/documents required to get a prize through the fault of the participants or other reasons beyond the Organizer's control;
- **6.3.2.** the participant's failure to fulfill the requirements stated in these Rules;
- **6.3.3.** the participant's failure to pick up his/her prize for any reason.
- **6.4.** By accepting the prize, the prize winner agrees to have their names as well as video and photographic materials created with their participation made available to the public in any manner at the sole discretion of the Organizer; or used by the Organizer in its audio, photo and video materials without any compensation or further notice. A person who shows the mobile phone to Organizer and/or at its regional division shall be deemed a real owner of such phone, provided that such person is a registered subscriber/owner of the phone's mobile number or has produced a sufficient proof of his/her rights (par 4).
- **8.3.** Organizer is not under an obligation to maintain written correspondence or provide explanations in respect of the requirements to the participant's eligibility for a prize pursuant to these Rules
- **8.4.** Organizer shall not be liable in case of defect in workmanship as well as technical and technological failures as may occur in Organizer's cellular communication networks or equipment.

- **8.6.** All disputes arising in connection with this Promotion must be settled by negotiations. Failing which, such disputes will be referred to Kazakhstan courts and settled through the procedure prescribed by RK laws.
